-Rnd 1 DSCC

-Rnd 2 KCC

-Rnd 3 BLCC

-Rnd 4 MMSC

SP reads event report. Despite damages and poor track conditions the event ran smoothly. CAMS commend the event operation.

-Rnd 5 SHSCC

No official report. JL describes that due to interference from the CAMS appointed steward, the Clerk of course and Scrutineers were not permitted to compete. The event was finished early due to dust. Past Meeting:

Minutes of previous meeting held 6/09/2012 read by J.L. Accepted by all

Business Arising from Past minutes:

- S.P. has migrated website and some issues remaining with spam which have been managed by restricting new members to require manual approval. Reports that multiple websites (Yahoo and VCAS website) are unnecessarily difficult to maintain.
 - J.L moves that S.P take action to decommission and close e-group by 11th May, seconded by J.C, Passed

- 2. Treasurers Report presented by S.P for Steve Porter
 - No business arising from report
- 3. Ballarat was not officially affiliated at previous meeting.
 - J.L. moves that the consensus by email for BLCC's affiliation be ratified. Seconded by Alan Bloomfield. All
 in favour.
- 4. J.L. proposes VCAS Life Member Scheme where life members will be eligible for free entry to VCAS events at the cost of the host club.
 - J.L moves that Scheme be incorporated into 2014 Rules. Seconded J.P, all in favour
- 5. J.L. proposes Nicholas Charrett be appointed Life Member in recognition of exceptional service to VCAS

- J.L moves for proposal to be accepted. Seconded by S.P, approved by all
- 6. S.P. moves to have Series Representative Rule from previous minutes included as amended "The club's appointed Series Representative or delegate shall be nominated in the supplementary regulations for each event. The Series Representative shall be an assistant to the Event Officials in matters of series eligibility and assist as a competitor relations officer (CRO). The Series Representative shall collect any scrutiny checklists and results to be returned to the committee."
 - J.L moves for proposal to be accepted as 2014 Rule. Seconded by S.P, approved by all
- 7. J.L. suggests combining classes A and B due to lack of competition
 - J.L moves for 2014 rules to be amended to combine both classes. Seconded by S.P. Passed 4 to 1. A.B. against.
- 8. J.L. raises discussions regarding clash of dates.
 - Committee discuss each round

 - Rnd 3 21/04/2013 Date change difficult due to track access issues at BLCC as advised by Arron Secombe via email.

 - Rnd 5 08/06/2013 Swan Hill VCAS is a special VCAS round capitalising on the long weekend.
 - Rnd 6 22/06/2013 Boisdale needs to stay on 3^{rd} Sunday of month to pull a full field of Maffra competitors and make event viable for host club.
 - Rnd 7 20/07/2013 MADCC date is not clashing
 - Rnd 8 24/08/2013 CCC date is not clashing, but venue is TBA
 - Rnd 9 14/09/2013 CCRMIT date is not clashing
 - Rnd 10 27/10/2013 RSM date is not clashing
 - Rnd 11 17/11/2013 Clashing with VRC/ARC, VCAS committee will request BCC to move 1 week earlier to 10^{th} Nov
 - Rnd 12 01/12/2013 Shepparton clashes with a non-VRC rally.
 - J.L. proposes that if BCC can move 1 week prior, date will be changed to 10th November, S.P. to contact BCC to confirm
